### 1. SMS Consent Communication

When you opt in to receive SMS communications from 3E, we collect your mobile number and any other necessary information to communicate with you via text messages. **3E does not sell, rent, or share your mobile number or SMS opt-in data with third parties or affiliates for marketing purposes.** We respect your privacy and are committed to keeping your data secure.

### 2. Types of SMS Communications

If you have opted in to receive SMS messages from Consolidated Electrical Distributors, Inc., DBA 3E you may receive messages regarding the following:

- Order status updates
- Delivery confirmations
- Invoice or billing inquiries
- Account management or follow-ups
- Appointment scheduling with account representatives
- Important company or service-related notifications

Example message:

"Hello, this is a friendly reminder of your upcoming appointment with 3E on [Date] at [Time]. Reply STOP to opt out of SMS messaging at any time."

### 3. Message Frequency

The frequency of SMS messages may vary based on the type of communication you are receiving. For example, you may receive up to [X] SMS messages per week regarding appointments, billing inquiries, or other related communications.
